
FAA requires registration for RC pilots flying outdoor aircraft including fixed-wing aircraft, not just multi-rotors or drones. You only need to register yourself and affix your registration number to all your aircraft. Pilots are required to have a hard copy or electronic copy of the federal registration certificate on them while flying. There is a \$5.00 credit card registration fee. The credit card transaction will be used to verify your identity.

# Blast from the Past



This series of articles will present advertisements from vintage modeling magazines. The intent is to illustrate technological advances that have taken place in our hobby. For some, it will bring back memories, for newcomers it will present a piece of history of radio control model aviation.

Here is an advertisement for the Baby Wasp motor from the February 1938 issue of Model Airplane News. According to the advertisement, this was a kit consisting of unfinished aluminum castings, materials and screws, blue prints and wiring diagram – you then put it together. If you are wondering what F.O.B. means, it is Free On Board - the shipment of goods delivered on board ship or other carrier without charge to the buyer (Collins English Dictionary, 2014) – I had to look this one up.

## *Special Rule for Model Aircraft - Update*

As we approach the July 15<sup>th</sup> deadline for FAA reauthorization, we wanted to provide a brief update on what’s happening in Congress. Right now, it looks like the House and Senate have agreed to an FAA extension with several policy provisions added. Though it is unknown what these policy provisions will specifically include or how long the extension will last, we are monitoring the situation very closely as Congress will likely vote on the final bill next week.

FAA’s recently released rule for small UAS used in commercial and civil operations will be highly beneficial to the UAS industry overall and will lead to widespread commercial and civil operations of unmanned aircraft.

**It is important to understand that the final small UAS rule does not change model aircraft operations for AMA members.** In fact, the rule affirms Congress’ intent in the Special Rule for Model Aircraft that the FAA will not add any additional regulations on our community. We are very pleased that the rule helps to maintain this exemption for model aircraft. Below are some commonly asked questions updated on July 5, 2016:

Q. Where can I read more about FAA’s final rule on small UAS?

A: You can read more at [www.faa.gov](http://www.faa.gov)

Q. How does Part 107 affect me as a member? Do I have to take a special test, receive certification, be capped at 400’, etc...?

A: The FAA final rule generally applies to all commercial and civil operations, but exempts hobbyists who “satisfy all of the criteria specified in section 336.” If you are an AMA member operating within our community-based safety program and are not conducting commercial operations, you are exempt from this rule.

Q. Do I still need to notify airports within five miles of my modeling activities?

A: Yes. This rule does not nullify the airport notification requirement.

Q. Do I still have to register with the FAA?

A: Yes. While the FAA codifies parts of Section 336, the new rule does eliminate the registration requirement for model aircraft operators.

Q. Do I need to put my FAA number on my model aircraft?

A: Yes, you need to list both your AMA number and Federal registration number on your aircraft.

# Kentucky Fall Classic 2016

The Lexington Model Airplane Club would like to invite you to attend the 12th annual Kentucky Fall Classic Fly-in. This event features a laid back atmosphere, great hospitality, great food, friendship and fun. This year we will be adding Sunday to the event giving us a fourth day of flying.

Location: Lexington Model Airplane Club, 4200 Hedger Lane, Lexington KY

Time: Day break until Dark. Flying before 9 am and after 4 pm will be open flying. Minimum wing spans apply, 80 inch mono plane, 60 inch bi-plane, true quarter scale or larger. Exception - Open flying on Thursday and Sunday.

Landing Fee: donation to charity of LMAC's choosing. LMAC is a 501 C3 organization. All donations are tax deductible. Tax documents can be provided if you would like to make a sizable donation.

We have eight 30 amp camper hookups available (electric only) \$10.00 per day or \$25.00 for 3 days. These are first come first serve. There is also room for primitive camping.

Pilots Dinner on Friday night - \$12.00 per person

The field features a 50 x 700 foot paved runway with a 50 x 700 foot grass running parallel to the pavement. A large overfly areas allows plenty of room for low passes and speed runs.

The field is located east of Lexington just off of I-64. From Lexington, take I-64 East to the Bluegrass Station exit (exit 87), proceed toward Bluegrass Station to Rockwell Road (1st road on the right), turn onto Rockwell Road and go about 1 mile to Hedger Lane. Go through the gates and follow this road for approximately 1 mile to the Lexington Model Airplane Facility
