It sure does feel like spring out there, but there are still about 4 more days of winter left before we can get to spring. That does mean we need to be ready for spring and summer and be up to date with the requirements for the FAA. The club does not check to see if you are up to date with all the FAA requirements, but you never know when an FAA inspector might just decide to visit the field.

You should first register with the FAA. There is a minimal cost with registering, but the registration last for several years. Put your FAA identification number on your aircraft where it can be found on the outside of the plane.

Take and pass the TRUST test. Don't worry the test is very easy and it will help you pass it without any problem.

Be sure you are flying at an approved FRIA (FAA-Approved Flying Site) or use a remote ID module. LMAC is registered as an approved FRIA site so there is no need to have a remote ID module at the field but if you are flying somewhere other than LMAC you should check to see if it is a FRIA site or if a module is required.

These requirements are there to keep our hobby safe with other air traffic and there is no logical reason not to cooperate with the FAA, so lets all try to do what we can.

Blast from the Past By David J. Price

This series of articles will present advertisements from vintage modeling magazines. The intent is to illustrate technological advances that have taken place in our hobby. For some it will bring back memories, for newcomers it will present a piece of history of radio control model aviation.

Here is an advertisement from the February 1964 issue of Model Airplane News for Fox Manufacturing Missile Mist fuel. I had the chance to fly U-control with Fox Missile Mist and it was good fuel, but expensive. A gallon in 1964 was \$5.50. Based on inflation, that gallon would cost \$54.72 in 2024.



Discretionary Enforcement of Remote Identification Ends Soon

On March 16, 2024, the FAA's discretionary enforcement period for remote identification (Remote ID) of unmanned aircraft systems (UAS) ends. The following is a quick refresher on the topic and how to comply.

Q: Who needs to comply with Remote ID?

A: All radio-controlled aircraft that weigh more than 0.55 pounds (250 grams) must comply. UAS include both traditional model aircraft and drones.

Q: How do I comply?

A: The three ways to comply are to operate a Standard Remote ID UAS; attach an aftermarket broadcast module to the UAS; or fly at an FAA-Recognized Identification Area (FRIA).

Q: How do I know if my UAS is equipped with Standard Remote ID?

A: Most in our community will not meet the Remote ID rule with this option, because only complete, off-the-shelf UAS will have standard Remote ID built in. If you do purchase a complete system and are unsure if it meets the requirements, you can search its serial number at this site: https://uasdoc.faa.gov/listdocs. If it is not found, it does not meet the requirements for standard Remote ID.

Q: How do I comply with the rule through the broadcast module option?

A: There are several broadcast modules currently available. They differ in price, features, and options, so it is important to choose the module that works best for you.

Q: Do I need to purchase a module for each of my aircraft?

A: No. Broadcast modules can be moved from aircraft to aircraft. You certainly can purchase more than one, but recreational operators are not required to have a module for each of their aircraft. Be sure to add the broadcast module to your FAA DroneZone dashboard.

Q: Where can I find a FRIA or determine whether my flying site has this status?

A: The AMA Club Finder tool has a filter option for FRIAs at www.modelaircraft.org/club-finder. You can search by city/state and check the box next to FRIA sites; only sites that are FRIA approved will be included in the search. The FAA's UAS Facility Map has also been updated to include FRIA sites across the country.

Q: How do I apply for FRIA status for my flying site?

A: Please send an email to fria@modelaircraft.org to get started.

June 22, 2021, UPDATED TRUST INFORMATION:

The AMA has now been approved to administer The Recreational UAS Safety Test, or TRUST. AMA has worked closely with the Federal Aviation Administration (FAA), ensuring that TRUST meets the intent of Congress without placing an undue burden on our hobby community.

Since 1936, the AMA has been dedicated to the hobby of model aviation, to educational programming, and safety in the airspace. We are offering the TRUST to the entire community of model aviation enthusiasts free of charge.

Make sure you are using the latest version of your browser (ex. Chrome, Firefox, Safari) to ensure the test runs as smoothly as possible.

On February 22, 2021, the FAA released information regarding the next step of implementation of the Recreational Knowledge and Safety Test. This step includes the application process for organizations interested in serving as test administrators for The Recreational UAS Safety Test (TRUST). See below for FAQs regarding the test:



TRUST FAQ's Continued

Q: What is "TRUST"?

A: "TRUST" stands for The Recreational UAS Safety Test

Q: Why do I need to take TRUST?

A: The Knowledge and Safety Test is a congressional mandate in the FAA Reauthorization Act of 2018. **All UAS users** must pass the test in order to operate a recreational model aircraft (UAS) within the National Airspace System (NAS).

Q: I have a Part 107 Certificate; do I also need to complete TRUST?

A: Part 107 does not dictate why you fly, whether for only business, fun or any other reason; you must only adhere to the Part 107 rule. However, if you wish to fly under the Exception for Limited Recreational Operations of Unmanned Aircraft rule (PL 115-254 Sec. 349/USC 44809), then you must take the TRUST.

Q: Are youth under the age of 18 required to complete TRUST?

A: Yes. There are no exemptions from taking the test, including for minors. Youth can get assistance from an adult, if needed.

Q: How often do I need to take the test?

A: At this time, recreational flyers only need to take the test once to comply.

Q: What will be on TRUST?

A: The test has 23 multiple-choice questions about basic safety guidelines and recreational flying knowledge that most AMA members likely already know. The test is fail-proof and every recreational user will be able to complete and pass the test.

Q: Does TRUST cost anything?

A: No. Test administrators are prohibited from charging a fee, either directly or indirectly, to individuals taking the test.

Q: How will I know that I have passed TRUST and am able to fly my UAS?

A: Once you complete and pass the test, your test administrator will provide you with a TRUST completion certificate that you can either print or save electronically. This certificate is proof of your compliance with the Reauthorization Act of 2018 and your passage of the test.

Q: Will TRUST affect my AMA membership benefits?

A: Proof of test completion will not be a requirement for AMA membership. However, each member affirms that they will follow AMA's safety code, including applicable laws and regulations, when he or she signs up to be a member.

Q: When will recreational users be required to take the test?

A: Recreational Flyers are encouraged to take the test as soon as practicable.
